TERM AND CONDITIONS

Possession of our price list does not constitute an offer to sell nor does it relate to the offer of distributorship

PAYMENT TERMS:

Our payment terms are Net 30. All accounts over 31 days are past due and will be assessed a service charge of 1.5% per month, 18% APR. Minimum service charge is \$1.00 per month. Accounts over 90 days are referred to our collection agency. A charge of \$30.00 will be added to all checks returned to American Airworks, Division of Ray Lambert Enterprises, Inc. Master Card, Visa, American Express, and Discover credit cards are accepted for payment. A 3% service charge will be applied to anyone paying an invoice with a credit card. Consumers sales tax is applied to ALL WV sales unless a current tax exemption certificate is on file with us. Payment of oldest invoice first is required.

RETURN OF MATERIALS:

Return of saleable materials will not be allowed beyond 30 days. There will be a 15% restocking fee on all goods returned with an approved RMA. In addition, return freight charges shall be the responsibility of the purchaser. This charge does not apply in instances where American Airworks, Division of Ray Lambert Enterprises, Inc., shipped products in error. An RMA must be obtained for return items. Non-stock and custom items are non-returnable.

LOST MERCHANDISE:

All claims for missing merchandise must be filed in writing within ten days of receipt of the goods or the claim will be rejected. Delivery to the carrier constitutes delivery to the purchaser. Claims for damages or items lost in shipping shall be directed to the carrier.

DAMAGED MERCHANDISE:

Merchandise that arrives damaged may be refused. If not refused, damage must be noted on bill of lading, otherwise the buyer accepts the package as received in proper condition.

WARRANTY:

We warranty our SURVIVAIR service work for six (6) months. We warranty our other products for a period of one (1) year. We pay return shipping one way on any returned warranty work.

SHIPPING:

Shipments to us should be by UPS, whenever possible, to 578 Robert C. Byrd Dr., Sophia, WV 25921. We add additional insurance to outgoing shipments of products, unless directed otherwise. Insurance, COD, handling and shipping charges are prepaid and added to your invoice and are payable to American Airworks, Division of Ray Lambert Enterprises, Inc.
